Jennings County United Way, Inc By Laws state that any person or corporation who contributes more than a specified amount becomes a member of the organization for the year and would be entitled to nominate and vote for a board member. All board members are independent and do not serve at the discretion of United Way members.

Form 990, Part VI, Line 7a - How Members or Shareholders Elect Governing Body

Any member of the United Way may nominate or cast their vote for a person who may be elected by the governing body. Once a Board member is elected he serves independently of United Way members.

Form 990, Part VI, Line 11b - Form 990 Review Process

A draft copy of the 990 was provided to all board members and the finance committee at the board meeting. All board members review the 990 for accuracy and direct any potential discrepancies to the finance committee. The finance committee is responsible for the final review and approval of the 990 prior to signing.

Form 990, Part VI, Line 12c - Explanation of Monitoring and Enforcement of Conflicts

Conflict of interest statements are signed annually by all board members and staff. Board members are not allowed to vote on any issues in which they have or appear to have a conflict of interest.

Form 990, Part VI, Line 15b - Compensation Review & Approval Process - Officers & Key Employees

No Board member is paid for their service as a United Way Board Member. The Executive Director's position is reviewed annually by the board and compensation is based on benchmarks and performance standards consistent with similar not-for-profit organizations pay scales and job responsibilities.
